

Families Exploring Spirituality - What's in the Bible? Sunday, February 1, 9:00-10:00 a.m.



Praying With Letters

A handwritten letter to elected officials is still one of the most powerful ways to act for justice. The Justice and Witness Ministry will host a simple meal, a brief time of worship and a chance for you to write letters about justice issues that are in your heart. There will be resources available focused on a particular justice theme each week. February 25 will be environmental justice with resources from Minnesota Interfaith Power and Light. March 4 will focus on economic justice. March 11 highlights justice in Minnesota with resources from Joint Religious Legislative Advocacy. March 18 offers immigration justice resources from Isaiah and March 25 is open to all of the above. People are also encouraged to write letters of advocacy for other concerns to which they feel called.

Justice and Witness Opportunities

Day on the Hill, Tuesday, March 10, 8:30 a.m. - 4:00 p.m.

There are a number of faith-based groups holding events during the 2015 MN Legislative Session, providing a well-supported opportunity for you to meet with your state legislators, become more engaged in the world of public policy, and witness for justice at the state capitol. For many years, CPUC has supported the advocacy efforts of the Joint Religious Legislative Coalition (JRLC). Their agenda for this year's legislative session

includes economic justice, voting rights restoration, human trafficking, and judicial elections, and it will include breakfast and lunch, issue briefings, and group meetings by district with representatives.

Minnesota Interfaith Power & Light 2015 Day at the Capitol Monday, February 2, 9:30 a.m. - 4:30 p.m.

The Justice and Witness Ministry is in process of meeting with the leadership of the Minnesota Interfaith Power and Light organization (www.mnipl.org) to consider an ongoing collaboration. (see www.mnipl.org). The Day at the Capitol agenda includes the Clean Energy and Jobs Campaign, calling on our legislators to support a responsible Minnesota Clean Energy Plan by increasing the Renewable Energy Standard. Registration begins at 9:00 a.m. in the church sanctuary of Christ Lutheran Church, 105 University Ave. St Paul, followed by Clean Energy Training at 9:30, meeting with your legislators at 11:00, and Interfaith Prayer Circle from 12:00 - 1:00 p.m. Even if you can't come to the whole day, please join us for this important opportunity to bring a moral voice to this work as we gather to lift up our witness and power through prayer and song for a healthy, sustainable future for all. Also throughout the day there will be activities in the fellowship hall including writing letters to the editor, hearing more from policy experts, participating in a community art project, and more! 
ISAIAH

The Justice and Witness team is exploring a potential partnership with this faith based advocacy group mobilizing for racial and economic equity in Minnesota. ISAIAH believes in the power of acting collectively in ways that are consistent with our faith values and the principles of democracy. Last fall ISAIAH conducted a Prophetic Voters campaign during the mid-term elections to reach out to those least likely to vote, not through a partisan effort, but through engaging voters around their deepest faith values and dreams for their communities, including economic dignity, racial justice, and the inclusion of all in our democracy.

Currently, ISAIAH is inviting churches to bring their members to the Capitol to engage in legislative visits, on a Tuesday or Thursday from February 19 to March 26. This would be a good opportunity to become more familiar with ISAIAH and their advocacy efforts. http://www.isaiah-mn.org/

Antiracism Study Dialogue Circles (ASDIC) Saturdays, March 7-May 16, 8:30 a.m. - 12:30 p.m.

Cherokee Park United Church is again hosting an ASDIC
Metamorphosis Circle. This reflective, interactive dialogue series is
designed for those seeking to better understand the ways race and racism operate
in our lives. ASDIC Circles enable greater clarity of thinking, strength of
relationship, and effectiveness of action in addressing systemic racism. Each week
(but no meeting April 4) participants gather to create a safe place for risk-taking,
community formation, and acting with care and confidence.

We are able to offer this training to two members at a much-reduced rate of \$150 because of our involvement and support for this group. (Corporations pay \$1400 per person.) Many of our congregation's leaders have participated and find it especially helpful and transformative for their impact on awareness and action.



ASDIC Circles also can now be taken for university/college credit through Metropolitan State University, Urban Studies Program, and School of Education, offering college or seminary students or ASDIC circle participants to take the ASDIC Antiracism Circle as a graduate or undergraduate course for three (3) units of credit; those students will follow assignments specifically designed to meet designed Course Outcomes. Cherokee Park United Church Annual Leader's Retreat The Rebirthing of God

Christianity's Struggle for New Beginnings
Friday and Saturday, February 27 & 28
at ARC Ecumenical Retreat Center, Stanchfield, MN



Focus: The retreat will provide an opportunity for leaders of Cherokee Park United Church to reflect on how our community of faith can be and is part of a fresh beginning for faith in our day. The primary resource for discussion will be *The Rebirthing of God* by John Philip Newell. The

author is a peacemaker and scholar who draws from the tradition of Celtic spirituality with a great affinity toward all traditions that share an awareness of the sacredness in all of life. He argues that Christianity in its present form is dying and something new is ready to be born. He draws on modern prophets from East and West who are showing the way, including Thomas Berry, Aung San Suu Kye, Mary Oliver, Bede Griffiths, Thomas Merton, Mahatma Ghandi, Carl Yung and Simone Weil. A copy of the book will be provided to all participants. It will not be necessary to have read the book. Brief summaries will be provided for discussion.

Location: It will take place at the ARC Retreat Center, a wonderful old lodge in a beautiful wooded setting near Cambridge, Minnesota, known for its superb vegetarian cooking! Linens are provided. There will be time for hiking on the grounds, fellowship and just relaxing.

Who should attend: Council members, ministry chairs and other leaders, as well as all interested members and friends. **Cost:** \$120 per person, which includes over-night accommodations and breakfast and lunch on Saturday. The cost also includes a copy of "Rebirthing God." Scholarships are available on request for whatever amount is needed. Contact Pastor Tim.
