Mardí Gras Celebration 2016 Saturday, February 6, 7-11 p.m.

Mardi Gras, French for "Fat Tuesday", has its origins in medieval Europe, when the wild Roman festivals of Saturnalia and Lupercalia were replaced a by the Christian rulers in power. First Sundays Food Collection

Foods and funds collected are donated to the Neighborhood House Free Food Store (formerly "Foodshelf") at the Wellstone Center. Over 2,500 pounds of food are distributed daily, serving nearly 10,000 households each year. 50% of those served are children and 90% live on incomes below the national poverty guideline. The Food Store now accepts **perishable foods**; more on this in the next issue.

to use our stories to bring about legislative change. This year with the challenges presented by the Capitol construction and a short legislative session, JRLC is taking Day on the Hill on the road and answering that very question.

Rather than a single day of action in St Paul, JRLC is hosting six Regional Days on the Hill to bring people of faith together to work for important social justice issues; events will include a meal, training, issue briefings, and a chance to take action. Metro venues are **February 23** in Fridley at the Islamic Center of Minnesota, 6 - 9 p.m., and **March 8** in Burnsville at Mary, Mother of the Church, 5:30 p.m. - 8:30 p.m. Registration Fees are \$15 until February 5 and \$20 thereafter. JRLC, founded in 1971, was the first interfaith public-interest lobby group in the United States. There are nearly 2.4 million people in Minnesota who identify themselves as having a religious faith that is connected to JRLC, representing about 48% of Minnesota's total population.

Ecclesiastical Council for Anna Larson


Cherokee Park United Church will host this council on Thursday, February 18, beginning with a light lunch at noon. An Ecclesiastical Council is comprised of delegates from United Church of Christ (UCC) congregations in Minnesota, primarily churches in the regional vicinity of the hosting church. This is the final step of approval from the UCC needed by those seeking ordination. The Ecclesiastical Council consists of a presentation by the candidate for ordination. questions and answers with those present, followed by discussion and a vote. Prior to this final step, candidates must have completed all other ordination requirements, including the prior approval of the Church and Ministry Committee of the Minnesota Conference UCC. The Ecclesiastical Council is open to all and members



of the home church are especially encouraged to attend.

Cherokee Park United Church became Anna's home church when she became a member while attending United Theological Seminary. Presently Anna is serving as a commissioned minister at Circles of Faith UCC in Waubun on the White Earth Reservation. A commissioned minister is a designation of the UCC that enables people to serve as pastors for a set period of time at a specific location without ordination. With approval for ordination Anna will be installed and ordained at Circles of Faith. Anna has been serving the congregation for the past year and seven months and at their recent annual meeting the congregation voted to call Anna as their pastor pending approval for ordination.

Pastor Tim graciously accepted his award reminding everyone it is all of our charge to keep working towards God's kingdom here on earth. This award was a fitting honor and acknowledgment of Pastor Tim's ministry in this community for the past 35 years.

Breakfast attendees enjoyed a nice meal and viewed the MLK Day breakfast celebration broadcast from the Minneapolis Convention Center. That was highlighted by an inspirational speech given by former Massachusetts governor, Deval Patrick.

A Congregation Committed to Antiracism

It is no easy thing for a predominantly white community of faith to speak openly and honestly about race, racism and the factors that continue making racism front-page concerns both locally and nationally. Like everyone one else, members of predominantly white congregations receive from their earliest formative years an outlook on the world that presumes that to be white is to be superior. Author Joe Feagin refers to this as the "White Racial Frame". It is a message reinforced by the telling of history, who and what gets lifted up and who and what gets ignored. Literature, music, and art created by whites are called classics and all other works of culture are assigned to some variation on ethnic work. In many Christian congregations of faith this subtle, but powerful naming of white as superior is reinforced with regular images of a white Jesus, surrounded by Nordic looking disciples with a cast of characters who are white. Children are introduced to these life-shaping images at a very early age.

Congregations of faith face other challenges as well in addressing race and racism. Belief in the value of confession and honest reflection provides a powerful tool for truth telling. But predominantly white congregations also share what author Robin DiAngelo refers to as "White Fragility", a state in which even a minimum amount of racial stress becomes intolerable, triggering a range of defensive moves. Most congregations prefer to avoid conflict whenever possible and conversations about race come laden with the potential for conflict.

Most surprisingly some of the deepest values for congregations of faith can become barriers to honest conversations about race. Many congregations greatly value a universalism enabling us to see each other as one in our humanity. It is born out of a belief that God's love is for all. The challenge occurs when this universalism collapses, as it often does, into whiteness as a dominant and superior norm for that universalism. Similarly congregations rightfully place a high value on reconciliation. But, reconciliation when placed ahead of the more difficult work of addressing historic and existing injustice, itself becomes a barrier to an open and honest discussion of race. In religious terms, unless reconciliation is preceded by acts of repair (reparation), it can become a form of cheap grace.

Cherokee Park United Church has struggled and continues to struggle with all these dynamics that form a wall to racial justice. We have found no simple answer other than to make a commitment to being an antiracist congregation and follow the path of that commitment wherever it leads. The journey has included such things as incorporating antiracism into the congregation's mission, infusing world music into worship, balancing the image of a white stained glass Jesus with images of Jesus from many lands and cultures, congregational wide discussion, celebrations honoring Dr. Martin Luther King, Jr. and Monsignor Oscar Romero and supporting

artists of color by hosting their exhibits. The commitment has opened up valued relationships with partners from El Salvador and an ongoing relationship with the Mendota Mdewakanton Dakota Tribal Community.

It is also out of this antiracist commitment that the congregation serves as the Fiscal Agent for ASDIC Metamorphosis (Antiracism Study Dialogue Circles), an award winning antiracism program bringing people together for study and community building, equipping them to address racism. Through Cherokee Park United Church, ASDIC was the recipient of recent Saint Paul Foundation Grants intended to help strengthen and build their capacity in doing antiracism work. Okogyeamon (Dr. Herbert Perkins) is the director of ASDIC, a member of Cherokee Park United Church and an influential voice in the congregation's ongoing work and commitment. In addition to ASDIC, Cherokee Park United Church is the Fiscal Agent for and co-sponsor of an Annual Overcoming Racism Conference held at Metropolitan State University in November, organized by FREC, the Facilitating Racial Equity Collaborative. Cherokee Park United Church continues struggling with and living into its commitment to be an antiracist community of faith.


